Dogs are welcome, although they must be secured at all times, and walked on a leash. Dogs and horses are not allowed near the chuck wagon area.

All riders must furnish feed for their animals. Hay and feed will be available for purchase at camp.

Make your reservation by completing the attached entry form and return it with the \$10.00 reservation fee which is applied toward the total cost of your ride.

Reservations received after August 15, 2017, will be charged a \$10.00 late fee in addition to the cost of the ride.

STATE REQUIREMENTS FOR YOUR ANIMALS

The State of Wisconsin requires EVERY HORSE or MULE to have a NEGATIVE COGGINS TEST and HEALTH PAPERS (Must have 2 copies of Health Papers -one to keep and one to give to Big Valley Ranch) and any other papers necessary.

MEALS

Dinner – 5:00 p.m. – 6:30 p.m.

IMPORTANT: ENTRY FORMS MUST BE RETURNED BY AUGUST 15, 2017, FOR OUR CATERER TO ORDER FOOD AND PREPARE THE MENU.

RIDE DETAILS

Ride details and schedules are announced one day in advance, if possible, and posted in the dining area.

FEES AND DUES

- ❖ **FIVE-DAY RIDE SEPTEMBER 4 - 8, 2017** - \$225.00 (Adult) \$140.00 (Kids) (includes \$10.00 Registration/2017 Membership Fee). This includes:
 - Registration/membership fee, meals, organized rides, organized activities, camping.
- ❖ **PART-TIME RIDE** - \$45.00 per day, plus \$10.00 membership for 2017. This per day charge includes:
 - One night camping, two meals, one day on the scheduled ride, and participation in scheduled activities for the day.
- ❖ **VISITOR PASS** - Visitor Passes are \$15.00 per day, per person, with a maximum purchase of two days of the five-day ride. The Visitor Pass includes:
 - One meal and scheduled activities for the day, **excluding the organized ride**. An additional meal may be purchased for \$10.00
- ❖ **ANNUAL MEMBERSHIP** - \$10.00 (August 1 – July 31).
- ❖ **RIDER VISITOR PASS** - \$10.00 per half day ride, plus \$10.00 membership for 2017. This pass is for those only coming to ride and not partake in any other activities. No Meals, No Camping, No Other Activities. Should you want lunch or partake in other activities you will need to pay the Part-time Rider fee.
- ❖ Camping is included in the five-day ride fee. **Camping with electricity with one pen (for up to 2 horses) \$30. Camping without electricity with one pen (for up to 2 horses) \$20. Extra Pens are \$10/night.** *You will need to make a reservation by downloading the reservation form from the ISSHA website (<http://ilstatestockhorse.org/100-mile-ride>). One shower house available. ***All camping fees prior to, during, and after the ride will be charged in accordance with the rules and regulations of Big Valley Ranch. You will need your receipt to be reimbursed for camping once the ride starts (Monday night through Friday Night, \$20 will be reimbursed for electrical camping per night and \$10 will be reimbursed for non-electrical camping per night)**

RULES OF THE RIDE: VIOLATION OF ANY RULE MAY RESULT IN YOU BEING ASKED TO LEAVE THE ISSHA IS NOT RESPONSIBLE FOR ACCIDENTS

- A trail boss and assistants have been appointed; their authority is absolute
- No rough riding, No racing
- No alcoholic beverages allowed on trails
- No stallions
- No food taken from the dining hall without permission
- Complaints against dog(s) may result in the owner being asked to leave
- The ISSHA reserves the right to reject any entry
- Quiet Hours - 12:30 a.m. – 5:30 a.m. (M – T) Friday night - 1:30 a.m. - 5:30 a.m.
